

MINUTES OF THE VILLAGE OF BROADVIEW
BOARD OF FIRE AND POLICE COMMISSIONERS
MEETING –April 14, 2025, at 5:30 PM

Call to Order:

Chairperson Gwenevere Turner called the meeting to order at 5:34 p.m. Chairperson Turner and Commissioner Jordan-Harper were present in person. Commissioner Tucker absent. Quorum present. Also present were Attorney John P. Wise, Chief Derek Bryant, Fire Department, Chief Thomas Mills and Deputy Chief Brandy Johnson, Police Department.

New Business:

Approval of Meeting Minutes: February 10, 2025: A motion was made by Chair Turner and seconded by Commissioner Jordan-Harper to approve the February 10, 2025, meeting minutes. Motion approved unanimously.

Discussion and motions related to status of testing and creation of Initial Eligibility Register for original appointment to position of Firefighter for the Village of Broadview Fire Department: Attorney Wise presented the Commissioners with the candidates' oral scores, written scores, total weighted scores, and Initial Eligibility Register. A motion was made by Chair Turner and seconded by Commissioner Jordan-Harper to approve the Initial Eligibility Register for original appointment to position of Firefighter. Motion approved unanimously. Chair Turner signed the Initial Eligibility Register. Attorney Wise explained the next steps in the process, including that a request for documentation from the candidates will be made related to preference points and after the timeframe for submittal has lapsed a Final Eligibility Register, including preference points, will be presented to the Commission for review and approval.

Discussion and motions related to status of promotional examinations and Preliminary Eligibility Register for Police Sergeants: Deputy Chief Johnson noted that twelve officers tested for the promotional exam. This includes both written and oral exams and she shared the results with the Commission. Chief Mills stated that the next step is the assignment of Chiefs Points. They believe one candidate has military experience for which they could seek preference points. She asked that an agenda item be included in the next meeting for establishment of the promotional list. Commissioners discussed holding a special meeting for the firefighter final eligibility register and the sergeant promotional list on May 2, 2025, at 4:00 p.m. or after.

Closed/Executive Session: Chair Turner moved to enter executive session for the consideration of appointment and employment of specific employees to the fire and police departments and discussion of minutes of meeting lawfully closed for purposes of approval by the body, seconded by Commissioner Jordan-Harper. Motion approved unanimously. Adjourn to Closed Session under 5 ILCS 120/2(c)(1) and Section 2.06.

Reconvene to Open Session: Roll call vote taken to establish quorum and reconvene open session. Chair Turner and Commissioner Jordan-Harper present in person.

Discussion and motions regarding the appointment of applicant from the Final Eligibility Register to the position of Entry Police Officer

A motion was made by Chair Turner and seconded by Commissioner Jordan-Harper to deny appointment to candidate #8 Dylan Alvarez. Roll call vote taken. Motion to deny appointment approved unanimously. A motion was made by Chair Turner and seconded by Commissioner Jordan-Harper to deny appointment to candidate #9 Jasmine Diaz. Roll call vote taken. Motion to deny appointment approved unanimously. Mr. Wise noted that the Final Eligibility Register for Entry Police Officer dated September 11, 2023, has now been exhausted.

Public Comment: None.

Attorney Wise passed out the meeting schedule to the commissioners.

Adjournment:

A motion was made by Chair Turner, seconded by Commissioner Jordan-Harper to adjourn the meeting. Motion approved unanimously.
